**Avis : Change Obligatoire**

Un minimum de US \$ 300 ou dans une monnaie acceptée et équivalente doivent être échangés en *Foreign Exchange Certificate* (FEC) 300 unités. C'est le minimum qu'un étranger doit dépenser pendant son séjour dans le pays et le FEC non utilisé ne peut en aucun cas être reconverti.

Si un étranger a changé plus que US \$ 300, le restant non utilisé du FEC peut être reconverti à son départ en montant le " FOREIGN EXCHANGE CERTIFICATE VOUCHER " au guichet des changes.

N.B : " Les enfants de moins de 12 ans "et " membres du Package Tours groups ( voyage organisé ) " sont exemptés .

**Notice : Compulsory Currency Exchange**

A minimum of US \$ 300 or other equivalent acceptable currency has to be changed with Foreign Exchange Certificate ( FEC) 300 units. This is minimum amount to be spent by a foreigner during his/her stay in the country and any unused FEC out of this amount will not be reconverted.

If a foreigner has exchanged in excess of US \$ 300, any unutilised balance of the FEC will be reconverted at the time of departure on presentation of the " Foreign Exchange Certificates Voucher " at the Exchange Counters.

Note: " Children up to 12 years " and " Members of the Package Tour Groups " are exempted..
